WITH 8 OF 12 VOTING MEMBERS PRESENT A QUORUM WAS ESTABLISHED.

2. PUBLIC INVITED TO ADDRESS THE COUNCIL: THERE WERE NO MEMBERS OF THE PUBLIC PRESENT.

3. PLAN FOR TAKING MINUTES: JANE LIGHT VOLUNTEERED TO RECORD THE MINUTES OF THE MEETING

4. APPROVAL OF AGENDA: CHERYL BAKER MOVED; MEL LIGHTBODY SECONDED; MOTION CARRIED UNANIMOUSLY.

5. APPROVAL OF JUNE 14, 2012 MEETING MINUTES: JODY MEZA MOVED; JAN ERICKSON SECONDED; MEL LIGHTBODY ABSTAINED, ALL OTHERS PRESENT VOTED YES.

6. APPROVAL OF FUNDS TO BALANCE NSCLS HEALTH CARE COSTS FOR RETIREES FOR FY12/13: THE ADOPTED BUDGET NEEDS TO BE AMENDED BY \$3200 TO ADD THE FUNDING REQUIRED FOR THE NSCLS PAYMENTS FOR RETIREE HEALTH CARE FOR THE REMAINDER OF FY12/13. THE SYSTEM NO LONGER HAS ANY FUND BALANCE OR OTHER SOURCE OF FUNDS TO PAY THIS. AT THE APRIL 25, 2012 COUNCIL MEETING, IT WAS AGREED THAT THE PUBLIC LIBRARY MEMBERS WOULD BE ASSESSED A "FAIR SHARE" AMOUNT AND FURTHER THAT A SPECIFIC OPTION FOR CALCULATING THE SHARE WOULD BE USED.

- DISCUSSION: IN APRIL, THE PROJECTED SHORTFALL WAS \$3900. THAT AMOUNT HAS NOW BEEN REVISED TO \$3200.
- COUNCIL MEMBERS EXPECT TO STOP PAYING HEALTH CARE COSTS FOR RETIREES AFTER JUNE 30, 2014. COUNCIL WANTS THE AFFECTED RETIREES NOTIFIED BY JUNE 30, 2013 TO PROVIDE CONSIDERABLE ADVANCE NOTICE OF THE CHANGE.
- COUNCIL ASKED PLS STAFF TO CONDUCT RESEARCH TO LEARN IF RETIREES CAN CONTINUE TO OBTAIN INSURANCE THROUGH CALPERS IF NSLS CEASES PAYING ITS CONTRIBUTION.
- JAN ERICKSON EXPLAINED THAT BECAUSE THE SHASTA LIBRARIES OPERATE UNDER CONTRACT WITH SHASTA COUNTY, SHE COULD NOT VOTE TO ACCEPT AN OBLIGATION FOR THE COUNTY AND WOULD INSTEAD ABSTAIN. WHEN AN INVOICE IS RECEIVED, SHE WILL FORWARD IT TO THE COUNTY.

MEL LIGHTBODY MOVED; JODY MEZA SECONDED; JAN ERICKSON ABSTAINED, ALL OTHERS PRESENT VOTED YES:

EACH MEMBER WILL PAY THE VARIABLE HEALTH INSURANCE BASE AMOUNT INCLUDED IN THE NSCLS RETIREE HEALTH INSURANCE ALLOCATION CHART AS OPTION 2 THAT WAS REVIEWED AT THE APRIL 25 2012 MEETING.

- THE AMOUNTS TO BE PAID ARE AS FOLLOWS: BUTTE Co \$500; HUMBOLDT COUNTY \$500; SHASTA \$400; ORLAND \$300; PLUMAS Co \$300; TEHAMA Co \$300; MODOC Co \$200; TRINITY Co \$200; WILLOWS \$200; DEL NORTE Co \$100; LASSEN LIBRARIES \$100; SISKIYOU Co \$100.
- PLS WILL INVOICE THE LIBRARIES.

7. ANNOUNCEMENTS: JAN ERICKSON ANNOUNCED THAT SHASTA LIBRARIES HAS RECEIVED A RULING ON A COURT CASE REGARDING WHETHER THE EXTERIOR AREA IN FRONT OF A LIBRARY AND THE LIBRARY PARKING LOT IS A PUBLIC FORUM. THIS RULING SET A LEGAL PRECEDENT THAT THE AREA IN FRONT OF THE LIBRARY IS A TRADITIONAL PUBLIC FORUM AND THAT THE LIBRARY PARKING LOT IS NOT A TRADITIONAL PUBLIC FORUM AND IS A LIMITED PUBLIC FORUM.

Item 5c Retiree medical insurance costs for FY 2012/13 (Annette Milliron)

Annette explained that NSCLS revenues are not sufficient to cover the estimated \$6,272 costs for the 2012-2013 fiscal year needed to cover the four remaining people on the plan at the minimum level required. Previously, NSCLS members agreed to the original retirement plan contract in 1972 (and subsequently if membership was entered into thereafter) and had agreed to pay these retirement costs through the 2013-2014 fiscal year. Options were discussed. NSCLS members will need to take action at a future meeting to determine how the group will provide the funds for this expense – perhaps via a special assessment for just this purpose. Members were advised to seek legal advice as their individual agency's liability for covering the insurance premiums.

No decision was made. This item will be placed on the agenda of the next Council Meeting.

- [Option] 1: Fixed base amount PLUS remainder based on average of budget and population data, and
- [Option] 2: Variable base amount on budget PLUS remainder based on average of budget and population data

A motion was moved to use Option 2. Moved by Jan Christofferson, Second by Jeff Hawkins. Motion carried with 5 yeas, 0 nays and 2 abstentions
