1. APPROVAL OF NORTHNET LIBRARY SYSTEM JPA, BYLAWS, AND STANDING RULES:

Derek Wolfgram explained that the documents for the new NLS system that the NSCLS Council had approved at their last meeting had been revised by legal counsel. The attorney recommended that the option of having a proxy for a board member be removed from the bylaws. A change was also made to the quorum set in the bylaws as it was proven at the first meeting of NorthNet Library System that having a simple majority is difficult. The quorum was changed to 2/5ths. David Dodd, NBCLS Board member reported at the NLS Council meeting last week that NBCLS has used that number for years and has had no problems.

Mr. Wolfgram also explained that the insurance coverage that is required of the NLS in the JPA can actually be carried by a member library so that change was made in the revised JPA to read that NBCLS will carry that coverage.

A Motion to approve the revised JPA and Bylaws was moved by Cheryl Baker and seconded by Jan Erikson. The Motion passed unanimously.

Mr. Wolfgram discussed a topic for the next NLS meeting which is how do NLS Council members keep their system's library directors up-to-date and also receive feedback from members in the new mega-system. He noted that this will be an important issue for the new system and one of the first things addressed by the Council.
