

Gov't Code § 54953(b)(4). A local agency may provide the public with additional teleconference locations. Cal. Gov't Code § 54953(b)(4).

The teleconferenced meeting must meet the following requirements:

- (1) it must comply with all of the Act's requirements applicable to other meetings;
- (2) all votes must be taken by roll call;
- the agenda must provide the public with an opportunity to address the legislative body at each teleconference location. Cal. Gov't Code § 54953(b).

Motion to approve Consent Calendar.

(Meeting Agenda, Minutes of AC Meeting of January 31, 2020)

Sass moved; Escobedo seconded.

Vote taken by roll call, all votes in favor, motion passed unanimously.

Old Business

Olawski reported on the NLS/CLSA Link+ Grant and the current status of expanding Link+ to other libraries in CA and expending grant funds. She also referred to the memo from NLS to the California Library Services Board (CLSB) included in this meeting packet for the CLSB June 25, 2020 meeting advising the Board of the grant status and requesting their direction for moving forward.

Frost commented that while significant efforts have been made by the Link+ Ad Hoc Committee and NLS staff to reach out to libraries who had expressed interest in joining Link+, at this time most libraries are finding it difficult to justify new services. Frost thanked Olawski and Fink for speaking at past CLSB meetings in support of Link+.

Fink stated that the options presented in the memo to the CLSB are good for their consideration and demonstrates their priority to expend the funds according to the grant timeline.

New Business

Perry reported on his inquiry to NLS membership via Survey Monkey regarding past participation and interest in Day in the District event and expressed his interest in exploring the value of a NLS consortia agenda. Nine responses were received from the Survey with a mix of experience, but most reported an interest in learning more.

Deck commented that he has found the relationships with his state legislators to be of great value.

Frost thanked Perry and Deck for putting this item on the NLS agenda. She continued to report that in the past, the California Library Association (CLA) used to encourage directors to visit their legislators in their Sacramento offices, however the push in the past few years is to visit

local legislators in their district offices with the goal to get to know your legislators. CLA encourages directors to invite local legislators to library programs and to build connections to get them engaged. Frost also commented that now is an important time to be advocating for your library. Frost noted that all NLS libraries benefit from state funded projects such as Lunch at the Library and Zip Books, both of which are to be zeroed out in the FY 2020/21 state budget. She continued to say that all but NLS member CSU Chico benefits from California Library Services Act (CLSA) funds.

Frost reported that CLA received an endowment to train library staff on advocacy skills and that PLP held a regional advocacy training for staff, Board members and Friends. She suggested that NLS consider this same opportunity for advocacy training. Frost also encouraged members to take photos of current alternate service delivery means, i.e. curbside pickup to demonstrate the value of library services to the community and the patrons and send those photos with narrative to local legislators.

Deck noted that he had reached out to local media with success to capture services as they are now being provided at his library.

Fink mentioned that Sonoma County Library coordinated a legislative meet and greet in 2019 for their region that was valuable.

Deck stated that NLS would continue to build on this idea.

Motion to Elect the slate of FY 2020/21 Executive Committee Members.

It was noted that Nick Wilczek, formerly of Humboldt County Library, will be the new director at Nevada County effective June 22, 2020. Perry requested that NLS consider a balanced reflection of the legacy systems on the Executive Committee.

Perry moved to elect the slate, with revision to Wilczek's location; Dodd seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

Deck presented the NLS *Preparing to Respond and Recover Together* LSTA application and noted this application is a continuation of the current NLS *Recovering Together* LSTA grant project.

Frost noted that all regional grants are included in meeting packets for approval and while this application has not yet been approved for funding by the State Library, the Administrative Council may make the motion to approve as presented.

Motion to accept the LSTA Regional Grant *Preparing to Respond and Recover Together*. Olawski moved; Fink seconded.

Vote taken by roll call, all votes in favor, motion passed unanimously.

Deck presented the CLSA Zip Books Agreement for FY 2020/21 and NLS to continue as Administrator on this grant.

Motion to accept the CLSA Zip Books Statewide Expansion Project Administrator for

FY 2020/21.

George moved; Sass seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

Frost presented the Attachment 7 memo and reviewed the FY 2020/21 NLS/PLP Administrative Baseline Contract and Additional Work including highlights of work completed in FY 2019/2020. Frost commented that her observation was that when NLS and PLP work together, that NLS has a stronger voice in advocating for grants and/or CLSA funding. Frost continued to say that PLP appreciates being the fiscal agent for NLS.

Olawski expressed her thanks to PLP for their support in keeping NLS on-track and to be thinking of NLS as opportunities or issues arise.

Motion to approve the FY 2020/21 NLS/PLP Administrative Baseline Contract and Additional Work. Perry moved; Hammond seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

Frost presented Attachment 8 and the memo regarding CLSA funding for FY 2020/21. Frost reviewed the memo that details the 50% proposed cut in CLSA funding in the preliminary State budget. The Governor's budget proposal indicated that if Federal funds were received, CLSA would be made whole again. The State Senate, however, has proposed an alternative budget that would reduce CLSA funding by \$1.5 million, taking the Baseline to \$2.1 million. This reduction would be permanent and any Federal funds received would not affect the reduced CLSA funding.

The NLS budget presented in this meeting packet is based on a 50% reduction in CLSA funding to NLS. The CLSB meets on June 25th, 2020. The State Budget may be approved by that date and amount for CLSA funds would be known at that time.

Frost reminded members that by law, CLSA is allocated to systems for their use in System Administration at 20% of allocation, and Communications & Delivery (C&D) at 80%. With a 50% reduction to the 20% of what can be used for System Administration, NLS membership fees will be required to cover the balance of this FY 2020/21 administrative contract. Frost noted that a portion of CLSA Communications & Delivery funds cover system expenses such as the NLS Zoom account, the 800#, and the NLS website and these expenses are paid first, with the balance of C&D funds allocated to NLS members. Frost reviewed the allowable C&D costs being those that allow for resource sharing among 3 or more library jurisdictions and the cost of delivery. Recently, much of NLS's CLSA allocation was directed to the NLS OverDrive consortia since resource sharing options are limited. Frost noted that by Executive Committee approval, \$120,000 of NLS funds currently held for OverDrive will be rolled over and applied to FY 2020/21 for NLS C&D expenses.

Frost thanked the NLS Executive Committee and Perry for their thoughtful review of balancing the needs of shared resources and all individual NLS member budgets. Frost noted that a preliminary survey was conducted to determine anticipated FY 2020/21 allocations from

members to the OverDrive consortia and it was determined that an estimated \$54,000 would be available.

Frost stated that, if the NLS Administrative Council wished to make any changes to the Executive Committee's decision, a motion could be made for approval.

Perry reviewed the consortia's RB Digital plan (formerly Zinio) and described a new all-in-one platform available. The cost to participate in this new plan would exceed the \$32,000 the Executive Committee has allocated to this resource. That amount would only cover the platform costs, with members needing to make up the difference for content.

Platt thanked all for their work to develop this budget and asked if additional funds were later made available from Federal funding triggers, would those funds add to the current budget. Frost confirmed that additional funds would add to the budget and that the Executive Committee would work with the consortia to determine how to allocate additional funds.

Discussion ensued regarding the consortia funding and the intent of members' prior allocations to OverDrive and RB Digital.

Frost suggested that staff will develop a more detailed survey to determine how members will allocate their additional CLSA funds for FY 2020/21. Frost noted here that a memo from NLS has been submitted to the CLSB for their June 25th meeting asking for their consideration to expand the definition of Broadband and other allowable C&D costs, including software to allow for curbside pickup. The Executive Committee will work on revising the Claim Form and any approved options or new items will be added.


Perry requested that the Administrative Council restore \$120,000 back to the consortia to allow for funds to be allocated to RB Digital and to support funding in FY 2020/21 to OverDrive as originally allocated by participating libraries.

Deck noted that the Executive Committee in making this difficult decision considered the long-term impact to secure NLS. He acknowledged the need for OverDrive as its usage has significantly increased for the consortia participants. However, the Executive Committee made the decision to reduce the consortia funding to support all NLS members.

Yon presented the FY 2020/21 Membership Dues and Fees schedule, noting that budgets are estimated at this time and will need to be updated as the delivery costs for NBCLS are still pending while finalizing the new delivery contract. Yon noted that member dues reflect an increase adjusted to CPI of 2.5%.

Motion to approve FY 2020/21 Membership Dues and Fees with revision after NBCLS delivery contract is finalized.

Perry moved; Fink seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.





Yon reviewed the memo of Attachment 10 and the NLS Budget. Yon noted that Communications and Delivery amounts need to be revised. He also noted that with Zip Books being defunded for FY 2021/22, the NLS budget of FY 2021/22 will have a reduction in revenue from what has been received from Zip Books grant administration fees.

Frost asked if the Administrative Council would approve this budget provisionally with an approval for PLP to work with the NLS Chair for possible changes.

Perry made the motion to amend the budget to restore the roll-over funds of \$120,000 from FY 2019/2020 to OverDrive and to reduce the FY 20/21 OverDrive budget by \$12,000 and increase the RB Digital budget by \$34,000 for FY 2020/21.

Strickler asked if libraries not participating in the consortia would be impacted if this was approved and effectively reducing the CLSA allocation to individual libraries.

Frost reviewed the C&D budget and how the requested motion would impact all libraries.

Perry reported that his proposal would reduce the total base by \$60,000 to each the base Population and base % of CLSA.

Strickler asked if a revised chart could be drafted to show the impact. She noted that that budget as is shows that the decision softens the blow for all members.

Deck asked for other comments.

Yon reiterated that members will have the option to allocate additional FY 2020/21 CLSA funds to OverDrive and RB Digital. Frost noted again that based on the preliminary survey, members are allocating \$54,000 to the consortia resources.

Motion to approve the FY 2020/21 NLS provisional budget as presented and approve PLP to work with the NLS Chair for any changes.

Veach moved; Fink seconded. Vote taken by roll call. Perry voted nay, all others approved. Motion passed.

Common Knowledge presented on Recovering Together project progress. Also discussed next steps in continued support among NLS members and building the website resources for this purpose. Clark and Cooley asked for NLS members to submit photos from post-disaster and recovery periods for the handouts and website.

Olawski offered to ask the Executive Committee to reach out to NLS members to submit photos.

Project Updates

The NLS *Preparing to Respond & Recover Together* project has completed the *Cohort Community of Learning* activity and one statewide *Wildfire Preparation & Response* panel discussion as proposed in the FY 2020/21 LSTA grant application.

NLS Preparedness Cohort

The cohort training consisted of ten NLS libraries that participated in a community of learning and practice to draft and/or further develop their local disaster response plans and policies. The ten participating libraries were Del Norte Library District, Marin County Free Library, Napa County Library, Roseville Public Library, San Rafael Public Library, Shasta Public Libraries, Solano County Library, Sonoma County Library, Tehama County Library, and Yolo County Library. Teams participated in 3 online training sessions to share progress and learn best practices from other libraries. Teams also received individual coaching calls with consultants over the course of 3 months to further develop their local guidelines and policies. A culminating meeting was held December 8, 2020 to showcase outcomes from the library teams. NLS Directors (other than cohort participants), State Library staff, the NLS LSTA Project Advisor and other guests also took part to learn about the impact of this collaborative training model.

Statewide Panel Discussions

The Statewide *Wildfire Preparation & Response Panel*, held on October 21, 2020, was a moderated panel of 3 guest speakers from libraries with expertise and experience in wildfire disaster response and recovery. Panelists were from San Diego County Library, Camarillo Public Library, and Sonoma County Library. Eighty-five people attended this meeting and survey responses overwhelmingly reported that the information discussed was valuable and would affect positive change in their communities.

A second statewide panel discussion focusing on *Mental Health Supports in Disaster Preparedness and Recovery* is currently being planned for spring 2021. The meeting will respond to the 2019 NLS survey, which indicated that mental health supports for staff, volunteers and patrons are a high need in most NLS communities. A save-the-date email and formal invitation will be sent out in coming weeks.

Expanding the Project Statewide

NLS submitted *an Intent to Apply* for FY 2021/2022 LSTA funding and received an invite to complete a full application, due February 24, 2021, to expand the *Preparing to Respond and Recover Together* project. The proposed Year 3 project will expand the NLS cohort training to a statewide model and will include a second NLS cohort, as well as 2 other cohorts from other CA public library systems. In addition, the statewide project will assist cooperative library systems in creating their own versions of NorthNet's "buddy system." Two new statewide convenings will help libraries develop skills in equity and inclusion to address the uneven impacts of disasters on underserved communities, in alignment with the State Library's focus areas. <u>LibraryRecovery.org</u> will also expand to share resources from across the state, staying relevant to changing

circumstances. The project administration team will be developing the draft application for review by the NLS Executive Committee before submitting on or before February 24, 2021.

Subject: Discussion of Formation of CLA Disaster Recovery Interest Group

Date: January 29, 2021

Background

At the June 2020 NLS Administrative Council, it was suggested that the NLS libraries consider developing a California Library Association Interest Group around disaster recovery.

The requirements for form an Interest Group include:

- ✓ Two or more CLA members that share a common interest may form an interest group. One of the two individuals must complete the application, and register as the official leader of the Interest Group.
- ✓ The application will be reviewed by the CLA Board for approval.
- ✓ The Interest Group must define the contribution that it will make to CLA and to the California library Community, and explain why there is a need for the Interest Group.

The formation of the group was discussed by the NLS Executive Committee. Suzanne Olawski from Solano County volunteered to be the lead agency in forming the Interest Group. It was requested that this be discussed by the Administrative Council to determine interest and at least one other CLA member willing to be a co-lead of the Interest Group.

Option: Join CLA Climate Justice Interest Group

Subsequent to the NLS Executive Committee meeting, a new Interest Group has been established: the CLA *Climate Justice* Interest Group. NLS staff recently spoke with the co-leader of the new Group. From this discussion we determined that there are mutual and shared goals in both the Climate Justice mission (https://www.cla-net.org/page/1191) and a statewide disaster preparedness, response and recovery group, and that combining efforts may strengthen the mission of both.

NLS is invited to attend an Orientation Meeting on February 4, 2021, at 6:00 p.m. to learn more about how we can collaborate to build on shared objectives incorporating both Climate Justice and Disaster Preparedness. (Meeting access information will be shared when available via email notification.)

Should this be considered a viable option for NLS, it is recommended that at least 2 NLS members agree to register as Interest Group members in order to codify the representation for NLS.

Note: Interest Group members are required to hold current membership with CLA.

UPDATE ON GOVERNOR'S BUDGET

On Friday, January 8, 2021, the Governor released the draft FY 2021/22 budget, which included:

- \$8 million in one-time funds to support "Shared Vision" grants. An initial round of funding was conducted in the fiscal year that ended June 30, 2020 to boost early learning opportunities and outside-of-school programming at libraries and deliver library services to harder-to-reach Californians an even more acute need in the wake of the COVID-19 pandemic. There were \$25 million in proposals submitted by libraries across the state for the initial \$8 million. This second round of funding will help address some of the unmet need.
- \$1 million to support delivering books and other materials through the online marketplace. (Zip Books) Faster and cheaper than traditional book delivery, the program has been used during the pandemic as a lifeline to community members -- often the elderly -- incapable of visiting the library.
- \$800,000 in ongoing funding to support summer lunch programs at local libraries. In 2019, 220 local libraries served 289,000 meals. During the pandemic, libraries served "Grab-and-Go" meals and learning kits. The State Library looks forward to working with other summer meals providers to ensure more of the 3 million school-age children eligible receive the nutrition they need to learn and thrive.
- \$500,000 in ongoing financial aid to defray higher broadband connectivity costs for local libraries.
- \$500,000 to support the Braille Institute, the state's partner in Southern California, in delivering library services to the visually impaired.
- Although not called out specifically, the budget does indicate \$1.8M which may be for CLSA. This remains a 50% reduction, carried over from the current budget.

Last year, the Governor's January preliminary budget included funding for Zip Books and Lunch at the Library, along with full CLSA funding, which were then removed or reduced in the Governor's May Budget Revise. Although lobbying was done for restoration, they were not included in the June finalized budget. Although we should remain hopeful that the above items remain in the budget, we should also be aware that this is a preliminary budget. Both Zip Books and Lunch at the Library funding has been identified as ongoing in the Governor's budget just released.



REMAINING AND FUTURE CLSA FUNDS

In FY 2020/21 the approved California State budget included a 50% reduction of CLSA funds. NLS was able to reallocate \$120,000 of prior-year funds to increase the allocations to libraries. In FY 2021/22, there are no prior-year funds available.

OVERVIEW

The NorthNet Library System (NLS) is one of the nine cooperative library systems in California. A map of the nine cooperative systems is included at the end of this memo for reference. NLS receives funds from the California Library Services Act (CLSA), and the funds are distributed by an agreed-upon menu of items. Some members have asked for a review of how these funds are distributed and requested that NLS review the menu of items. The NLS Executive Committee has asked that this document be developed to explain this background.

The purpose of this memo is to provide the members with an overview of the CLSA and how funds can be spent, so that they can feel more confident in making decisions on how CLSA funds are allocated to the public libraries within NLS.

BACKGROUND OF CLSA FUNDS

One of the major reasons that the nine library cooperatives throughout the state were formed was to receive funds from the California Library Services Act to support resource sharing. Only cooperatives can receive these funds – an individual library may not directly receive them. In or about 2008, the California State Library requested that cooperatives consolidate to form larger cooperatives. The North State Cooperative Library System, Mountain Valley Library System and North Bay Cooperative Library System joined together to form the NorthNet Library System in 2009.

The California Library Services Act is defined in Title 5 of the California Code of Regulations, sections 20100 – 20265. The distribution and oversight of the funds is done by the California Library Services Board. Only public libraries may receive these CLSA Communication and Delivery funds.

CLSA funds can only be spent as defined in the Communications and Delivery section of California Law.

Beginning in FY 2011/12, funding for CLSA began to shrink, with the loss of a central System Reference and reimbursement for Transaction Based Reimbursement (TBR). In FY 2011/12, there was no funding for CLSA, and much hard work was done by several stakeholders and the CLA Lobbyists to restore funding, although at a significantly reduced level.



In FY 2016/17 and 2017/18, the cooperative systems and the California State Library staff worked with the California Library Services Board to update the regulatory language. The references to funding to support system reference and inter-library loans has been removed, and the definition of Communications and Delivery was updated. This allowed the systems to be more flexible in sharing resources and expand sharing of digital items.

By law, the funds are distributed as follows:

20% System Administration

80% Baseline for Communications and Delivery (C&D)

Each section is clearly defined for allowable costs. Below is a very brief checklist of how CLSA funds may and may not be used. The list is used for illustrative purposes, and if a system wants to use funds in a new way, it must first be approved by the State Library staff, and, in some cases, approved by the California Library Services Board.

20% System Administration

Can be used to pay for some of the staff time for oversight of a system. For NLS this includes some of the time of the System Coordinator, PLP CEO and PLP Controller for administering CLSA activities.

80% Baseline Communications and Delivery (C&D)

CLSA funds may be used for an individual library or a cooperative to support the network, "which may also include telecommunications equipment and its installation along with service fees." This was clarified at the June 2020 CLSB meeting to include one-time use of funds for network hardware purchases, and, for rural libraries only, for CENIC telecommunications costs and costs for covering warranties for network security software and hardware in data centers.

Based on the latest interpretation by the CLSB, libraries should not claim funds on an annual basis for 'broadband.' The NLS FY 2020/21 CLSA Claim form has been updated to reflect this, and to clarify that only rural libraries can claim funds ongoing to support their CENIC telecommunications and networking costs/warranties.

Although the law provides a framework for allowable expenses, it is up to each of the nine cooperative systems to determine the best way to allocate their funds. No two systems allocate them exactly the same.

Annually each of the nine cooperative library systems must submit a preliminary budget to the State Library for the CLSB approval by June. A full budget is submitted by September 1. An Annual Report and budget expenditure are also submitted by September 1.

ANNUAL AWARD AMOUNTS TO SYSTEMS FROM CLSB

At the August 2013 California Library Services Board meeting, the Board approved allocating the funds to the nine cooperative systems using the following formula:

- 30% awarded on the basis of the first three members of each System, equally;
- 45% for each System's combined portion of the total state population and System membership, excluding the first three members per System;
- 25% of each System's combined portion of full membership and round-trip mileage of the System's service area.

Notes: The phrase 'first three members' is a complicated explanation that is not needed for the purpose of this memo. It has to do with the structure of the legacy systems within each of the nine cooperative systems. The roundtrip mileage in the third bullet pertains to the sharing of physical materials. This is why the law specifies that members in a system need to have contiguous borders between participating libraries, and not geographically distant.



In FY 2011/12, there was no funding for CLSA. With advocacy, funds were restored, and after several years, the annual total amount of CLSA funds to be shared among systems was approximately \$3,630,000 annually.

In FY 2020/21, due to the pandemic, the amount was reduced by 50%, to \$1,880,000 to be shared among all the nine cooperative systems. NLS's FY 2019/20 allocation was \$820,118, which included \$164,024 allocated to System Administration (20%) and \$656,094 for the Baseline Budget (80% C&D). In FY 2020/21 NLS's allocation was \$417,929, with \$83,586 allocated to System Administration (20%), and \$334,343 allocated to the Baseline Budget (80% C&D).

It is important to note that library systems have three years from the receipt of funds to spend the CLSA funds.

NLS CLSA FORMULA FOR LIBRARIES

In reviewing past NLS documents, it is not clear when NLS developed the cost share formula but it does appear that it has been in existence since FY 2012/13:

50% of funds divided by population of each member library 50% of funds divided among each member library



For each library, once costs for Delivery, OverDrive & RBDigital are claimed, the library may choose a disbursement to be used for limited, specific approved uses. If a library doesn't have enough CLSA allocations to cover their costs, they are invoiced for the difference. In most cases, this is because the cost of delivery exceeds their allocation.

CLSA FUNDS AND THE NLS BUDGET

The NLS FY 2019/20 CLSA allocation was \$820,118, with \$156,716 for System Administration, and \$663,402 for Baseline Communications and Delivery (C&D). Below is the budgeted allocation. eResources includes Link+.



Below is an overview of the number of libraries participating in one of the choices.



Note the entire cost of delivery is not covered by CLSA funds for seven libraries. The additional revenue from the libraries to cover the remainder of costs.


In FY 2019/20, the OverDrive allocation was increased by the Committee as indicated above. Two libraries decided not to continue participation in RBDigital due to the increase in






Q3 Is your library able to select items from the current menu of resources?






Q10 If the cost of participating in the NorthNet RBDigital eMagazine platform increased, would you still participate?







Cultural Collections Protection Survey

The state is conducting a comprehensive survey of California's archives, galleries, historical societies, libraries, museums, and tribal nations to better understand and protect cultural collections in a time of increased risk and limited resources. The goal is for this survey to be an instrument to educate decision-makers about the value of investing in the state's arts and cultural heritage. The survey was sent out in November. The State Library will be gathering survey data through February 22, 2021.

The existence of these unique collections that help tell California's story is often unknown, particularly at the state level. Many rare and unique materials are at significant risk from natural disasters exacerbated by climate change, inadequate storage facilities, scarce resources, and simple decay over time. The Cultural Collections Protection Survey aims to close this information gap by gathering data on the nature and condition of California's culturally significant assets. It takes 30 minutes to 60 minutes to complete – and the result will be well worth the small time commitment.
