

Brown Act: The legislative body of a local agency may use teleconferencing in connection with any meeting or proceeding authorized by law. Cal. Gov't Code § 54953(b)(1). A "teleconference" is "a meeting of a legislative body, the members of which are in different locations, connected by electronic means, through either audio or video, or both." Cal. Gov't Code § 54953(b)(4). A local agency may provide the public with additional teleconference locations. Cal. Gov't Code § 54953(b)(4).

The teleconferenced meeting must meet the following requirements:

- (1) it must comply with all of the Act's requirements applicable to other meetings;
- (2) all votes must be taken by roll call;
- (3) agendas must be posted at all teleconference locations and the meeting must be conducted in a manner that protects the statutory and constitutional rights of the parties or public appearing before the body;
- (4) each teleconference location must be identified in the notice and agenda and each location must be accessible to the public;
- (5) during the teleconferenced meeting, at least a quorum of the members of the legislative body must participate from locations within the boundaries of the body's jurisdiction; and
- (6) the agenda must provide the public with an opportunity to address the legislative body at each teleconference location. Cal. Gov't Code § 54953(b).

1. Welcome and Roll Call

Meeting called to order by NLS Chair, Suzanne Olawski, 9:02 a.m. Olawski welcomed attendees, new Directors and acknowledged Hammond in their upcoming retirement. Chair asked for the roll call. Attending:

Lena Pham, California State Library, in attendance and to report in Item 6.


Olawski noted that items were carried over from January 2022 Mid-Year Meeting as a quorum was not met for voting at the Mid-Year Meeting (meeting locations were incorrect).

Motion to Approve Consent Calendar: Bankhead moved; Fuchs seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

4. Old Business

A. Review and Acceptance of NLS Study of CLSA Cost Share Formula and Allocation of Funds and Next Steps

Olawski presented the CLSA Study report and stated that the Executive Committee recommends approval of this report to the Administrative Council. Olawski noted that current CLSA allocation formula (Option #1 in the report) was favored by 70% of the NLS





membership who had responded that the current formula was working well. Olawski continued to note that Formula Option #5 that paid mandatory costs up front and distributed the remaining funds among members did benefit a few members, but negatively impacted others. She noted that the Executive Committee agreed that Option #1 worked best for the majority of members.

Fink noted that the chart provided on page 83 of the packet shows how libraries are impacted by the various formula options and agreed that the current formula is best for the majority of members.

Olawski opened the floor for discussion. Fuchs stated that she liked the current formula for the 50% divided equally and stated that this calculation was most important to her. She requested that another option be considered that would divide the remaining 50% of funds using a factoring of 25% to lowest service population size and 25% to most geographically isolated libraries. Fuchs noted that a focus on the geographically isolated libraries is of great value and benefits the most in need.

Olawski noted recommendations made in the report that include: revision to the NLS CLSA Claim Form; additional eligible items for consideration; additional funding for Library-to-Go eBooks and eMagazines. She noted that these recommendations will be included in the Strategic Priorities work to be discussed later on the Agenda.

Perry stated that he felt it would be worthwhile to bring the recommendations back to the Executive Committee and the Administrative Council with new Directors' input and for NLS to advocate to the California Library Services Board (CLSB) to further expand options for CLSA eligible expenditures.

Meza agreed with Perry's points and emphasized that more CLSA eligible options were needed.

Fink stated that these recommendations will be taken into consideration with the Strategic Priorities review and implementation.

Discussed a Motion to 1) accept report from the consultant, and 2) continue with the current CLSA allocation formula (Option #1). Bankhead moved; Fink seconded.

Duran asked if the report was completed and if the suggestion by Fuchs could be added to the consultant's contract. Olawski reported that the consultant's scope of work had been completed.





George asked what the term of commitment would be should Option #1 be approved at this time and noted that she agreed with Perry that new Directors should have input. She also stated that she would like more opportunity for discussion. George stated that Option #3 is of interest to her.

Olawski stated that this item is on the Administrative Council meeting agenda to allow for discussion and the study established a baseline for the current and future options in how CLSA funds are allocated. She also stated that there was no on-going commitment for the Option approved now but preferred that there be continuity for a period of time or until the next period of review.

George recommended that discussion be held outside of an Action Item.

Fink reported that the Executive Committee reviewed and discussed this item in detail to consider all options and the impact on different libraries. He acknowledged that most NLS members benefited from Option #1. He stated that there could be more discussion and numbers could be run again.

George stated that she did not agree with the assumption that selecting the Option that benefits all or most members is the best and that maybe the option that benefits the most in need should be considered.

Platt stated that he agreed that running other numbers would be interesting to see the impact. He also stated that more CLSA eligible options for expenditures is the larger issue, as more funds don't offer benefits if options are limited. Platt asked if the current formula needs approval to be used now and wait to further discuss on any changes for the future.

Bankhead suspended the Motion as previously stated. He continued to state that he feels Formula Option #1 is best but supports the suggestion to wait for additional input and is open to considering other options in the future.

Motion to Accept the CLSA Study Report and Formula Option #1.

Bankhead moved; Fink seconded. Vote taken by roll call. No Votes – Fader Samson, George, and Fuchs. All other votes were in the affirmative. Motion passed.

Olawski noted the following as Next Steps for the Executive Committee to address: 1) Consider a 6th funding formula to address Fuchs' suggestion; 2) Explore options to broaden choices; 3) Consider amending the Consultant's contract to develop a 6th Formula for future discussion. Revisit outcomes at future meeting.



Frost expressed her thanks for the thoughtful discussion and offered the following suggestions:

- For the NLS Budget discussion on this Agenda, the Administrative Council may consider allocating additional funds to continue the CLSA Study with requests made by members.
- Being mindful of new Directors, the NLS Chair and NLS staff will include CLSA and how the formula and allocation works in the onboarding orientation to new Directors.
- Each Legacy System (MVLS, NSCLS and NBCLS) could hold a Special Meeting specifically for the discussion of CLSA.

Frost continued to note that by law, CLSA funds are for the sharing of resources among three or more libraries. She also pointed out that vendors must be able to meet that criteria. Frost reminded the Council that Fuchs had made extensive research on vendors who met the resource sharing criteria and this could be revisited in considering the expansion of CLSA eligible options. Frost suggested that an Ad Hoc group(s) could be formed to look at these vendors as well as to revise the Claim Form.

Fuchs asked for clarification regarding CLSA eligibility with OverDrive purchases of a library's own collection but shared through their Advantage account. Fuchs noted that from her research there were some streaming services that were interested in the NLS consortia but did not meet the resource sharing criteria.

Frost confirmed that if the Advantage Account collection is shared immediately with three or more libraries (not reserved solely for its own library), it is CLSA eligible and stated that this would be revised to be more clearly identified on the Claim Form.

Frost had also verified with the State Library that purchases from the Palace eBooks-For-All Project collection and shared among three or more libraries are CLSA eligible.

Lovell expressed her thanks for considering expanded use of CLSA funds and that the discussion regarding CLSA eligible expenditures was helpful.

Discussion regarding Kanopy and new pricing model.

Duran asked how other NLS members were using their CLSA funds. Olawski referred the Council to the NLS Budget chart that identifies consortia funding amounts. Frost noted that MARINet shares within its membership and offered to compile a listing of NLS libraries and their individual allocations for the Mid-Year Administrative Council meeting.



Olawski asked that NLS staff bring the following to the Mid-Year meeting for Council review:

- Additional CLSA Communications and Delivery (C&D) eligible options
- Revised Claim Form

5. New Business

A. Election of Executive Committee Members for FY 2022-23

Olawski thanked the nominating committee for contacting nominees.

Motion to approve Slate of Nominees to Executive Committee: Chair, Mark Fink; Chair-elect/Vice Chair, Anthony Halstead; Executive Committee members: Jennifer Baker, Narinder Sufi, and Nick Wilczek. Duran moved; Fuchs seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

B. Approve the FY 2022-23 NLS Budget Membership Dues and Fees

Yon presented the NLS FY 2022-23 budget and noted that there were typos in the memo, but that the Budget pages reflected the correct figures. Yon continued to state that the FY 2022-23 budget was a 5% increase over the prior year. Yon discussed other points of the budget to note, including that the Staff Development funding was restored and was increased to \$1,500 per member library. Yon also noted that the Executive Committee had approved use of the \$50,000 CLSA funds earmarked in FY 2021-22 for "Special Projects" to be spent in the FY 2022-23 budget for the following: \$25,000 to offset increased delivery/courier service fees, and an additional \$25,000 to be allocated to the Library-to-Go consortia.

Discussion and questions answered regarding the format of the budget.

Olawski requested that funds be set aside to continue the CLSA Study as discussed earlier and suggested that \$5,000 - \$10,000 be considered for this project.

Frost noted that funds for the consultant would reduce the contribution to the Fund Balance by \$10,000 (from \$52,977 to \$42,977)

Olawski also proposed that \$100,000 of funds be moved from the Fund Balance to Operating Reserves.

Hammond agreed to this proposal and that moving funds to Operating Reserves was a good idea.

Discussion of the NLS Operating Reserves Policy (page 87 of Agenda packet).



Motion to allocate \$100,000 from Fund Balance to Operating Reserves, and to set aside up to \$10,000 to amend contract with CLSA Study consultant, Diane Satchwell, to continue research on NLS CLSA formula options. Olawski moved; Hammond seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

C. Approval of Recommendations by Ad Hoc Strategic Priorities Committee
Fink presented the Ad Hoc Committee memo and recommendations. Fink noted that
based on discussion at this meeting, CLSA Study results and continued research into
options would be included in the Strategic Priorities and Committee work. Fink
reported that the Committee is set to meet again in mid-July. Fink opened the floor for
questions.

Perry proposed to add in Tier 1 priorities a Budget "Literacy" item and requested that the NLS budget be less opaque. Fink agreed to add this item.

Olawski thanked Fink and the Ad Hoc Committee members for their thoughtful work in developing this initiative.

Fink suggested that this Agenda Item be tabled until the NLS Mid-Year meeting to allow the Ad Hoc Committee to continue their work and flesh out items as suggested, and to allow the Executive Committee time to review and comment.

NO ACTION TAKEN – Item will be added to the NLS Mid-Year meeting, January 2023.

- D. Approval of OverDrive Reciprocal Lending with MARINet and Peninsula Library System Platt presented the memo regarding the proposal of a Reciprocal Lending Agreement and the Executive Committee's recommendation to approve NLS joining the Reciprocal Lending between MARINet and the Peninsula Library System. Platt noted the following benefits of this consortia:
 - No cost to NLS
 - Significant increase in number of items available to NLS
 - Accessed through the OverDrive Libby application

Platt also noted the following: The RLA is at this time for eBooks and eAudiobooks; RLA only works with the Libby application; there is a required annual spending limit, but Platt noted this will be negotiated and will be conservative. Platt stated that MARINet is set up and ready to begin sharing at this time, while PLS estimates it will be ready in August.

Motion to approve NLS joining the OverDrive Reciprocal Lending with MARINet and Peninsula Library System.



Discussion regarding the benefits to other consortia members. Platt noted that benefits include increased access to unique collections of each member. Frost noted that OverDrive was curating consortia collections that were similarly sized and that complemented each other. Frost also stated that the agreement could be rescinded if necessary.

Fuchs moved; George seconded. Vote taken by roll call. Sacramento Public Library abstained. Motion passed.

Veach asked about unique titles.

Fuchs asked what the process to rescind the agreement would include. Platt responded that all points would be negotiated and include a written notice to rescind. NLS would consult with the other two systems before any change was made to the agreement.

Platt thanked Perry for his chairmanship of the Library-to-Go Committee and his work on this Reciprocal Lending Agreement.

E. Consideration of Establishing NLS List-Serv for Assistant/Deputy Directors

Olawski presented the memo and reported that the Executive Committee discussed the merits of creating a new and separate listserv from the Directors listserv.

Hammond stated that she had proposed the new listserv to create a space that would groom and prepare Deputy Directors for a larger role in their organization in the future. The space would be intended to allow for networking, sharing of ideas, and a community of learning. The space would be intended for information sharing only.

Discussion ensued regarding Director participation on this new listserv. Brooks mentioned that they do not have a Deputy and so would not have representation on this listserv.

Motion to create a new listserv for Assistant and Deputy Directors. Hammond moved; Fink seconded. Vote taken by roll call. Alpine County and El Dorado County abstained. Motion passed.

6. State Library Report

Lena Pham presented the State Library report and noted that the FY 2022-23 Zip Books and CopyCat programs were expected to roll out in the coming weeks.

Members asked questions related to specific funding opportunities. Pham referred members to the State Library contacts for specific projects.



Discussion regarding Zip Books and frustration with processes since the State Library took over administration. Several NLS libraries have dropped out of Zip Books due to the onerous billing processes required. Perry offered to assist libraries who need assistance in moving to the Amazon business model required for participation.

Olawski thanked Pham for her attendance and information.

7. Announcements

George recommended that the new listserv be monitored by NLS staff and not by Directors.

Hammond agreed that the Directors should not be included.

Brooks agreed the list should not include Directors, even though El Dorado County would not be represented.

Frost asked for clarification as to how NLS was to monitor the list. George suggested that Frost and/or Brinkley be included to monitor activity. Frost requested that neither she nor Brinkley be required to subscribe to the list, and that if participants had issues, they could contact Frost or Brinkley for assistance.

Fink thanked Olawski for her leadership to NLS, and thanked Frost and Brinkley for their support.

Fuchs recommended to all members to take photos of all their branch facilities for disaster preparation. Fuchs also thanked all members for their support to Plumas County after the 2022 wildfires and destruction of the Greenville library.

8. Adjournment

Meeting adjourned at 11:17 a.m.

California State Library Building Forward Infrastructure Program Update January 26, 2023

The Governor's January Proposed Budget for 2023/24 includes the following:

Support for Local Library Infrastructure — The 2021 Budget Act provided \$439 million one-time General Fund to support local library infrastructure projects. The 2022 Budget Act provided an additional \$50 million and assumed an additional \$100 million in 2023-24 to support local library infrastructure projects. The Budget proposes delaying the \$100 million to the 2024-25 (\$33 million), 2025-26 (\$33 million), and 2026-27 (\$34 million)

 We are currently preparing Round Two of the Building Forward Infrastructure Program. This grant opportunity will open in the first quarter of 2023. An announcement from State Librarian Greg Lucas is expected soon. With new funding providing the legislature, the State Library has approximately \$174 million dollars left to award.

NorthNet Library Systems libraries received \$52.7 million dollars in funding. Please see the next page for a complete list of projects.

Date: January 26, 2023

At the January 2022 NorthNet Library System (NLS) Administrative Council meeting, the NLS Strategic Priorities activities were reviewed, and an Ad Hoc Committee was formed to develop a new set of NLS Strategic Priorities. The members include Mark Fink, Chris Cooper, Christopher Platt, Lana Adlawan and Rita Lovell.

The Ad Hoc Committee developed a draft Strategic Priorities and presented them to the NLS Administrative Council at the June 2022 meeting. At that time, the Ad Hoc Committee requested additional time to enhance the document.

The initial NLS strategies and goals were adopted in May 2010. In light of continually changing economic support, new service trends and new NLS leadership, a fresh look at system activities focused on clarifying and identifying strategic priorities was undertaken in FY 2015/16. These priorities are extremely useful in identifying impactful services for member libraries and are informing recommendations to the California Library Services Board, the Board that determines the services provided by NLS and other California Library Services Act (CLSA) systems.

Adopted 2016 NLS Strategic Priorities:

The NLS Administrative Council, at its January 25, 2016 meeting, adopted five key strategic directions for NLS:

- Member Asset Mapping
- Sharing People and Knowledge Platform
- Training and Development/Facilitation and Capacity.
- Budget Cycle Alignment for Increased Collaboration/Purchasing

Since this list was developed the NLS libraries, through discussion at the Administrative Council meetings, have developed additional priorities, including:

- CalPERS Obligations of Legacy Systems
- Disaster Recovery and Response Training
- Shared Link+ Contract
- Shared eResources
- CLSA Study



Ad Hoc Committee Recommendations:

The Committee is proposing that NLS adopt values that inform its strategic priorities. In addition, the Committee has identified Tier One and Tier Two priorities.

NorthNet Values:

In the work that NLS undertakes, member libraries are committed to:

- 1. Making decisions that are sustainable over time
- 2. Practicing environmental stewardship
- 3. Integrating diversity, equity and inclusion principles in our decisions and work
- 4. Collaborating with one another
- 5. Being transparent and effective communicators
- 6. Staff capacity building, training, and professional development

Tier One Priorities:

The Ad Hoc Committee is recommending that NLS adopt the following Tier One priorities:

- 1. Disaster Preparedness and Response
 - Expand the role of libraries as disseminators of emergency information and emergency preparedness workshops/training/education to our local communities.
 - b. Identify and invest in the next phase of the work NLS has already done, including maintaining the *Recovering Together* website, and offering focus groups and training on this resource.
- 2. Future of Shared eResources

Assess eResources and platforms offered by the State Library and how this impacts NorthNet libraries in the short and long term.

- 3. Capacity Building for Staff Our Most Valuable Asset
 - a. Organizational culture
 - b. Diversity, Equity and Inclusion
 - c. Staff engagement
 - d. Staff collaboration
 - e. New employee training
 - f. Soft skills training
 - g. Staff recruitment
- 4. Investigate NorthNet joining the Government Alliance on Race and Equity (GARE)
- Shared Collection Management and Resource Sharing
 - a. Discuss member libraries' ongoing commitment to share resources
 - b. Investigate the question: should NLS subsidize shared collections?

Tier Two Priorities:

The Ad Hoc Committee is recommending that NLS adopt the following Tier Two priorities:

- 1. Monitoring CalPERS liability for the legacy systems
- 2. Advocacy
 - a. Member libraries receive advocacy training from American Library Association (ALA).
 - b. Define the role that NLS can play as an advocate for federal and state funding for libraries.
- 3. Maximizing the effectiveness of NLS training and communication practices, with an emphasis on:
 - a. Educating members on how NLS is structured
 - b. Identifying items for which CLSA funds can be used
 - c. Clarifying procedures to roll over unspent CLSA funds to the next fiscal year
 - d. Developing a new CLSA claim form

Recommendation

The Ad Hoc Committee recommends that the newly-formed Ad Hoc Committee start with Tier 1 and identify working groups from among all NLS members to get others involved.

BACKGROUND

The original CLSA Cost Share Study Report, developed by Library Solutions hired by NLS, was presented to the NLS Administrative Council at the June 2022 meeting. At that meeting, Chair Olawski presented the item, noting that that current CLSA allocation formula (Option #1 in the report) was favored by 70% of the NLS membership who had responded that the current formula was working well for them.

Some members expressed a desire to see some alternative models with a focus on the geographically isolated libraries, stating this would be of great value and benefit to those most in need rather than selecting the Option that benefits all or most members.

The Council approved Option #1 to be used for the FY 2022-23 budget (with five options being presented).

At the August 2022 NLS Executive Committee meeting, the Committee approved spending up to \$10,000 from the original Library Solutions contract to consider additional options for CLSA allocations, including models that address:

- 50% of funds allocated for each library, 25% of funds go to the lowest service population size, 25% of funds go to the rural geographically isolated libraries, and a narrative to explain the distribution and determination of categories;
- 1/3 of funds allocated to each library, 1/3 of funds go to the lowest service population size, 1/3 of funds go to the most geographically isolated libraries, and a narrative to explain the distribution and determination of categories;
- Define and explain lowest population size;
- Recommend alternate options in addition to requested formulas.



ADDENDUM REPORT CREATED IN SEPTEMBER

Exhibit A is the addendum report provided by Library Solutions in September 2022. The original report contained five options. The addendum report continues with that enumeration, with the additional reports commencing with Option #6. The consultant created eleven additional options: 6 A-D, 7 A-D, 8 and 9.

In this report, the consultant notes:

- To define a low or small population size, after considering various factors, she has arrived at 20,000 and 50,000 as benchmarks.
- She notes that 'various formulas created similar models. There are many possible scenarios, but the allocation of funds becomes very close within libraries. One metric is library budgets. Library budgets can be misleading. Large budgets may be the result of staffing needs, facility maintenance, or various local costs. This could result in lower discretionary money for collections.'
- Using tiers, reverse distributions, etc. resulted in similar results.
- Larger library systems also are the larger loaner and this could equate to allocating funds for those non-residents.
- Do the smaller libraries have the capacity to spend the additional funds within the threeyear requirement?

Based on her findings, the consultant did not have a recommendation.

The addendum was discussed at the October 2022 NLS Executive Committee. An Ad Hoc Committee was formed, comprised of Suzanne Olawski, Christopher Cooper and Deborah Fader Samson to work with the consultant on any potential additional formula options.

SECOND ADDENDUM REPORT IN NOVEMBER

Exhibit B is the second addendum to the report by Library Solutions which does not include any new models but rather highlights key points from the previous reports for Council discussion. The addendum also includes an Excel spreadsheet showing all options as well as individual tabs for each option showing gain/loss per library.

The consultant's conclusions do not recommend any one model but notes:

 Member libraries need to take into consideration that the larger allocation from the State for NLS CLSA funds already is based on a formula with consideration of geographically isolated libraries.



- The current model attempts equity.
- Equity is a challenge.
- Member libraries must consider how much they are willing to reduce their CLSA allocation to support geographically isolated libraries.

AD HOC COMMITTEE ANALYSIS AND RECOMMENDATIONS

The Ad Hoc Committee reviewed all reports and discussed the various options and the challenges of achieving equity in a system as vast and diverse as NorthNet. There is not one option that benefits all rural libraries. If a new formula is selected, some rural libraries will see their current funding levels decrease. Butte, Lake, Shasta, Woodland and Yuba have the least options (two or three) of gaining additional funding followed by Humboldt, Mendocino, Nevada, Placerville, Sutter, Tehama, and Yolo (five options).

The Committee discussed two potential options that were not part of the consultant's reports but rather their own formulae. **Exhibit C's** formula [Option 10] (50% Population, 25% Rural, 25% Vast) increases funding to 10 rural-vast libraries by \$14,828 and decreases funding to all other libraries by \$1,348 or \$8,088. A rural-vast library has a geographic service area over 2,500 sq. mi. and includes Humboldt, Lassen, Mendocino, Modoc, Mono, Plumas, Shasta, Siskiyou, Tehama and Trinity.

Exhibit D's formula [Option 11] (50% Population, 25% All, 25% Rural) provides additional funding of \$2,696 to each of the 24 rural libraries, decreasing current funding for all non-rural libraries by \$4,044.

The Committee did not come to a unanimous recommendation, rather it recommends the Council consider the following options to focus discussion of CLSA funding formula models:



Option 1: 50% CLSA funds divided equally among all member libraries and 50% distributed based on population

- 70% of NorthNet member libraries voted that the current model works for them
- 30% of NorthNet member libraries feel they are not served by this model as no consideration is given to the rural-ness or remote-ness of member libraries
- Maintains current funding allocation

Option 6c: 50% to all libraries based on population, 25% to rural libraries and low service population, 25% to geographically isolated

- Half of all funding still based on population
- Takes ruralness of libraries (geographically isolated) somewhat into account (25%)
- Takes smaller populations (under 50,000) somewhat into account (25%)
- Alpine, Colusa, Del Norte, Lassen, Modoc, Mono, Orland, Plumas, Siskiyou, Trinity, Willows gain \$13,358
- Other rural libraries <u>lose</u> \$1,348 and non-rural libraries <u>lose</u> \$8,088

Option 8a: 50% based on population, 25% based on low collection budget, 25% based on ruralness

- Half of all funding still based on population
- Provides 25% of total allocation to rural libraries
- Adds 25% of total allocation to libraries spending less than 7.75% of budget on collections
- Most rural libraries gain \$5,685
- Alpine, Butte, Colusa, Lake, Shasta, Woodland, Yuba <u>lose</u> \$1,348
- Non-rural libraries lose either \$1,055 or \$8,088

Option 8b: 34% based on population, 33% to low collection budgets (less than 7.75% of total budget), 33% to geographically isolated

- Reduces allocation share based on population
- Increases allocation to smaller rural population
- Butte, Lake, Shasta, Woodland, Yuba <u>lose</u> between \$418 \$4,049
- Belvedere-Tiburon and Benicia gain either \$686 or \$1,037
- Non-rural libraries <u>lose</u> between \$23 \$40,124


Option 10: Rural-Vast: 50% based on population, 25% to rural, 25% to vast service areas over 2,500 sq. mi.

- Half of all funding still based on population
- Increases allocation to geographical vast rural libraries
- Humboldt, Lassen, Mendocino, Modoc, Mono, Plumas, Shasta, Siskiyou, Tehama, Trinity gain \$14,828
- Other rural libraries <u>lose</u> \$1,349 and non-rural libraries <u>lose</u> \$8,088

Recommendation

The NLS Administrative Council may consider all options presented in the report. Option 1 is the current option which was agreed upon at the last Administrative Council meeting, and was the formula used for the last several years.


Should the NLS Administrative Council adopt another formula, it would need to be determined if it would be effective for the FY 2023-24 budget or the FY 2024-25 budget.

Background

NorthNet is a Northern California multi-type library consortium comprised of forty public library jurisdictions, one academic library and one law library. Only NorthNet public library members were considered in this study, as the California Library Services Act (CLSA) and its funding only apply to public libraries. The public library members are Alpine County, Belvedere-Tiburon, Benicia, Butte County, Colusa County, Del Norte County, El Dorado County, Folsom, Humboldt County, Lake County, Larkspur, Lassen County, Lincoln, Marin County, Mendocino County, Mill Valley, Modoc County, Mono County, Napa County, Nevada County, Orland, Placer County, Plumas County, Roseville, Sacramento, St. Helena, San Anselmo, San Rafael, Sausalito, Shasta County, Siskiyou County, Solano County, Sonoma County, Sutter County, Tehama County, Trinity County, Willows, Woodland, Yolo County, and Yuba County.

NorthNet is a joint powers authority created in 2009 by combining three existing cooperative systems: Mountain Valley Library System, North Bay Cooperative Library System, and North State Cooperative Library System. This was part of an effort supported by the CLSB and the State Library to consolidate library systems throughout the state, to achieve greater efficiencies and economies of scale. Members of these three legacy systems now receive their CLSA funding through NorthNet, but the systems maintain their separate existences and memberships, and still meet and make decisions about cooperative programs.

NLS member libraries requested a study to provide options to allocate funds and the findings of the study were submitted in a report to NLS in April 2022 with suggested formulas to allocate the CLSA funds. The study was carried out as follows:

- A survey was given to the eight other California cooperative library systems, to gather overall information about how they use and manage their CLSA funding.
- A questionnaire was administered to NorthNet member library directors (or a designee). This
 questionnaire was designed to determine any benefits and challenges related to NorthNet's
 current CLSA processes.
- One-on-one interviews were conducted with a subset of NorthNet library directors (chosen by the NorthNet Chair and Vice Chair), to gather in-depth information, perspectives and ideas regarding allocation and use of CLSA funding.
- Additional data points were reviewed, including NorthNet historical documentation such as surveys, claim forms, memos, and formula spreadsheets.

Member libraries reviewed the report and determined they wanted more options with the goal to create equity, the libraries with the smallest resources will receive larger allocations.

Addendum- Alternate Options for Allocation Formulas

The Consultant was tasked with the following:

- 50% of funds are allocated for each library, 25% of funds go to the lowest service population size, 25% of funds go to the rural geographically isolated libraries, and a narrative to explain the distribution and determination of categories;
- 1/3 of funds are allocated to each library, 1/3 of funds go to the lowest service population size, 1/3 of funds go to the most geographically isolated libraries, and a narrative to explain the distribution and determination of categories;
- Define and explain lowest population size;

Consultant will recommend alternate options in addition to requested formulas.

Formula Process

The first step in the process was to define what determines a low or small population size. There are different definitions of what determines a small population and there is no consensus on the best metric. The National Academies of Sciences stated small populations are "the size, dispersion, or accessibility of the population of interest makes it difficult to obtain adequate sample sizes to test specific research questions." The research did not specify a number to define small populations. The Census states small towns as incorporated areas with 5,000 residents or fewer define small populations. Some studies stated any area less than 50,000 was considered small.

For the purpose of this report, lowest population size was determined by using two metrics. Using 5,000 provided funding to only one library system, Alpine County. Using 10,000 provided funding to only four library systems. The intent was to consider how to allocate funds with the greatest impact. The Consultant used 20,000 and 50,000 as benchmarks for allocations. Each category (20,000 and 50,000) was further broken down to only include rural and also all populations.

A table is included to briefly describe the 11 (eleven) formulas presented in this report. The formulas can be found in Appendices A, B and E.

Using options 6A and 6B in Appendix A, two allocation formulas were created that provided funding to only rural libraries with populations of 20,000 or less (7 libraries) and all libraries in NLS with populations of 20,000 or less (13 libraries), using 50% - 25%- 25% split. Options 6C and 6D allocated funds based on populations of 50,000 or less.

Options 7A to 7D in Appendix B used the same metrics but illustrates the 1/3 - 1/3 - 1/3 split. Again, two examples for each population, creating four options.

The formulas from the original study are in Appendix C to make comparisons.

Appendix D is a summary of options from the original report.

Appendix E includes three options created by the Consultant. Using the two requested splits (50%-25%-25% and 1/3-1/3-1/3), the Consultant created allocation formulas using the percentage of library budgets used for collection development. According to the California State Library-Public Library Statistics-Fiscal Year 2020/2021-Library Expenditures-Total Operating Expenditures on Collection. The median percentage is 7.32, average is 7.74, maximum is 18.50, and minimum is 1.04. The consultant used the average total operating expenditures on collection. Option 8A is the result of allocating 50%-25%-25% split of funds to all libraries of 50,000 population or less with collection expenditures of 7.74 or less. Option 8B is the result of allocating 1/3 -1/3-1/3 split of funds to all libraries of 50,000 population or less with collection expenditures of 7.74 or less.

It was determined to use the collection metric as CLSA funds are for resource sharing. Allocating funds to those libraries that have lower spending levels will hopefully increase their percentage of spending on collection development. The intent of this model attempted to create the ability to increase funding to share their collections within the cooperative.

Option 9 is a 50%-50% split allocation formula. All libraries will have an equal portion of 50% of CLSA funds and libraries with collection budgets of 7.74 or less to split 50% equally. This model provides more funds to be allocated to libraries that do not have the ability to spend on collection development at a level that is considered average for California libraries. It also uses a metric from the California State Library reporting.

Various formulas created similar models. There are many possible scenarios, but the allocation of funds become very close within libraries. One metric is library budgets. Library budgets can be misleading. Large budgets may be the result of staffing needs, facility maintenance, or various local costs. This could result in lower discretionary money for collections.

Appendix F is the updated population figures for 2021-22. To maintain comparable data, the Consultant used the same figures from the original report (2020-2021) for the formulas in this report.

Description of Formula Allocations

The following table is a description of the 11 formulas developed to illustrate the various scenarios using the metrics listed above and alternate options created by the Consultant:





Introduction

NorthNet Library System requested a study of the California Library Services Act (CLSA) cost share formula and allocation of funds in April 2022. In September, an addendum was requested. Most recently, a summary of all options with comparisons was requested. A total of sixteen formula options were created for review by NLS Administrative Council.

The following points were used to create the formula options (Appendix A):

- Provide alternate funding models to achieve equitable resource sharing.
- Determine models to provide additional funding to geographically isolated and rural libraries.
- The ZipBook model was used to determine rural libraries.
- Include current model.
- Funds can only be used for resource sharing between three or more libraries.

This report reviews all sixteen options. An excel spreadsheet was developed to show all the total allocations of each option by each library. Individual tabs were set up to compare current model with individual options. The gain/loss was calculated to assist libraries in determining the most equitable, yet supportive formula for each member library. The gain/loss columns show the difference if you do not stay with option one.

Analysis

The challenges in creating the formula options were as follows:

- · Define equity.
- Define rural libraries.
- Minimal financial impact to libraries.

Addressing the challenges:

- Equity must be determined by member libraries- the initial goal was to help rural libraries within the consortium, so they could become stronger participants.
- Member libraries need to take into consideration that the larger allocation from the State for NLS CLSA funds is based on a formula of the geographically isolated libraries.
- The list from the original ZipBooks' program was used to identify rural libraries.
- Libraries are faced with keeping the impact on their library at a minimum when determining the allocation of CLSA funds.

Summary of Options

The comparison chart for each option as compared to option 1 shows the difference for each library if they decide not stay with option 1. For example, Alpine would receive \$15,330 with Option #6D. Staying with Option #1 would be \$7,166 less for Alpine. The following points summarize/highlight the options:

- Using only the population metric, a large disparity is created and does not meet the goal of equity. (Op 2) But adding additional funding to rural libraries creates a more equitable model (Ex- Op 3 & 4)
- Paying all invoices results in minimal allocations for some libraries. (Op 5)
- Splitting the CLSA funds so all libraries receive a percentage and adding to the rural libraries has the least impact to the larger systems, but a huge increase to the rural libraries. (Ex- Op #6D)
- Using the percentage model for collection has a smaller impact on most libraries, but a significant advantage to rural libraries. (Op #8)
- And some options create a larger loss for the bigger systems. (Op #9)

Conclusion

Highlights:

- CLSA funds allocated to NLS provides additional funding due to the geographically isolated libraries and should be a consideration when choosing a formula.
- The current model attempts equity.
- Resource sharing is required between a minimum of three libraries.
- Equity is a challenge.
- Member libraries must consider how much they are willing to reduce their CLSA allocation to support geographically isolated libraries.

Option #2: Population only

Option #3: 75% split by population, 25% split to rurals (\$6,740 each)

Option #4: 75% split by population, 25% split to libraries with budgets under \$2m (\$7,703 for each)

Option #5: Pay all resource sharing and invoice libraries the difference owed if they spend over the allocated funds.

Option #6A: 50% to all libraries based on population, 25% to only rurals and low service population (under 20,000 for \$23,109 each), 25% to geographically isolated (\$6,740 to each).

Option 6B: 50% to all libraries based on population, 25% to all libraries with low service population (under 20,000 for \$12,443 each), 25% to geographically isolated (\$6,740 to each).

Option 6C: 50% to all libraries based on population, 25% to only rurals and low service population (under 50,000 for \$14,706 each), 25% to geographically isolated (\$6,740 to each).

Option 6D: 50% to all libraries based on population, 25% to all libraries with low service population (under 50,000 for \$8,514 each), 25% to geographically isolated (\$6,740 to each).

Option 7A: 1/3 to all libraries bases on population, 1/3 to only rurals with populations under 20,000 (\$30,812 to each), and 1/3 to geographically isolated (\$8,987 to each).

Option 7B: 1/3 to all libraries bases on population, 1/3 to all libraries with populations under 20,000 (\$16,591 to each), and 1/3 to geographically isolated (\$8,987 to each).

Option 7C: 1/3 to all libraries bases on population, 1/3 to only rurals with populations under 50,000 (\$19,607 to each), and 1/3 to geographically isolated (\$8,987 to each).

Option 7D: 1/3 to all libraries bases on population, 1/3 to all libraries with populations under 50,000 (\$11,352 to each), and 1/3 to geographically isolated (\$8,987 to each).

Option 8A: 50%-25%-25% split using all libraries under 50,000 service population and collection % of budget 7.74 or less- 50% to all libraries based on population, 25% to low collection (\$7,033 to each), and 25% to geographically isolated (\$8,987 to each).

Option 8B: 1/3-1/3-1/3 split using all libraries under 50,000 service population and collection % of budget 7.74 or less- 1/3 to all libraries based on population, 1/3 low collection (\$9,377 to each), and 1/3 geographically isolated (\$8,987).

Option 9: 50% split equal to all libraries based on population, 50% to libraries with collection budgets of 7.74 or less (\$14,066.434).

Subject: Consideration of Kanopy and Filmocracy as Shared Resources

Date: January 26, 2023

Background:

Over the last three years, NLS member libraries have been surveyed to identify interest in shared resources. The most recent study on California Library Services Act (CLSA) cost share formula and allocation of funds included the following findings for priorities of interest:

- Video streaming (44%)
- E-newspaper (27%)
- E-comics (22%)
- Cloud e-books (3%)
- Miscellaneous suggestions included online auto repair manuals, Consumer Reports, SimplyE, and a subscription to a community analysis tool (such as Gale Engage).

At the June 2022 NLS Administrative Council meeting, there was further discussion about Kanopy as a shared NLS resource, and if CLSA funds can be used for a subscription. Lindsay Fuchs, Renee Forte, Christopher Platt and Carol Frost have done research on behalf of NLS regarding shared video streaming services. The purpose of this memo is to discuss these topics.

Discussion:

Kanopy

Kanopy offers documentaries, independent films, foreign films, and has a growing children's section.

In its current state, Kanopy's model is one library/one use, which does not meet the CLSA requirements of a resource being shared among three or more libraries. The exception is for the shared Kanopy resource by Marin County Free Library, Larkspur Library, and San Rafael Public Library, through a shared ILS.

NLS has held several discussions with Kanopy to revise their model to meet the CLSA requirements. They have committed to explore the technical issues to develop a model.

Sixteen NLS libraries expressed interest in Kanopy as a potential use for CLSA funds, seven of which already or were about to add Kanopy as a service for their individual library system. Each library has its own monthly cap and range from 1,200 to 105,650 active cardholders. (Active

cardholders are Kanopy's definition of "active cardholder," which is that the patron has had some action on their account in the last year.)

Kanopy has developed a discounted rate for NLS library systems who want to or already have Kanopy as a service. Kanopy currently offers three payment options:

- Kanopy pay per view. The library sets a monthly cap of how many credits are used per patron and/or a monthly budget, so the monthly total cannot exceed a specified amount. There is no platform or other associated cost.
- 2) Kanopy PLUS, which is a yearly subscription service with four themed collections of 250-300 films.
- 3) Capped Program: Capped programs offer libraries a fixed cost for a year's worth of Kanopy usage. Cost is dependent on the number of active cardholders and population statistics for the library, and it is determined by Kanopy's Finance team. Capped program costs vary year to year based on overall usage of the program by patrons during the previous contract year.

Per Kanopy's discounted rate, if together <u>new</u> libraries signing up meet a specific commitment level (the amount of funds that a library wishes to dedicate to usage of Kanopy in one year, under the pay per view or PLUS payment options), NLS libraries (new and existing) will receive a discount. As more libraries join and the next threshold is met, the discounts increase for all the NLS libraries. Discount levels are available in perpetuity. As soon as the first threshold is reached, the applicable discounts for new and existing Kanopy libraries can start.

- 5% off all PPUs for \$20,000 in new account commitments
- 10% off all PPUs for \$40,000 in new account commitments
- 15% off all PPUs for \$70,000 in new account commitments

Per **Exhibit A**, Kanopy offered estimated pricing for capped programs for NLS libraries. This is subject to change depending on negotiations with the Kanopy account executive. Each library would contract with Kanopy, rather than an NLS shared contract. Individual libraries should notify Kanopy that they belong to NLS to participate in the discount program. To date, only one new library has completed the paperwork to join the discount program.

Filmocracy

Filmocracy is a video streaming film and festival hosting platform which hosts about 3,500 permanent films and 6,000 rotating films, depending on which festivals are currently being streamed. Films also include original programming, panels, director Q&A's, and live networking opportunities. These films are often in the film festival stage, which means before they reach the distributor stage and therefore it is the first chance to see most of these films. (Films are usually removed from the platform after the festival is over; unlike in-person festivals, Filmocracy works to expand the length of the festival to last longer, usually a month. The

vendor also offers distribution to filmmakers after the festival is done, and videos like Q&As and panels are often permanently added to the platform.) Filmocracy provides foreign and domestic films before they become available to a wider audience through studios, personal streaming services like Netflix, and theater showings, letting library patrons have first access to films that would otherwise be unavailable and may never be shown outside of the film festival circuit.

Filmocracy also offers the ability to create private screenings, branded virtual spaces, and are open to new ideas to create community engagement.

Filmocracy offers two payment plans:

- Pay per view model.
- Flat model: Filmocracy has an annual cost based on the library's active patron cardholder count, with Filmocracy's definition of "active cardholder" that the patron's account has been used at least once in the last eighteen (18) months.

(Filmocracy does not have an additional cost for the platform itself or other associated costs.)

Filmocracy has indicated they can create a sub-domain for NLS to create a centralized collection which is eligible to use CLSA funding. They may either create a centralized single page and single URL where the patron will choose their library from a drop-down menu, and then enter their library card; or libraries could have their own individualized URLs to the shared collection. Each library will be able to set up its own authentication process, though they prefer and are ready for SIP2 as the authentication process.

If all sixteen libraries who expressed interest in Kanopy joined Filmocracy, this would represent close to a total of 228,573 active patrons for \$51,428.92/year. (The patron count of 228,573 is based on Kanopy's active cardholder definition of 12 months, not Filmocracy's 18 months, and

therefore will likely be at least several hundred cardholders higher. If we assume an additional 5% of active cardholders for the additional six months for a total of 240,002 cardholders, at tier \$0.225 it would cost \$54,000.45/year for the sixteen libraries.)

Considerations:

NorthNet has limited funds to spend. While Kanopy and Filmocracy offer different content to patrons and are not quite comparable, both are video streaming services. Kanopy is now integrated into OverDrive, where both NorthNet and CLSA funding is already directed to, and the OverDrive Reciprocal Lending Agreement requires a committed annual level of funding. NLS members should decide if they prefer funds be spread across vendors to offer more options to patrons or be concentrated among one or two trusted vendors.

Filmocracy is highly interested in breaking into the library market, making them receptive to library requirements and wants. The State Library has confirmed their model would be eligible for CLSA funds. They are an unlimited *not* capped program, which provides patrons with higher usage ability without affecting current or future pricing. However, as a new vendor entering their first year with libraries as consumers, there may be some unexpected bugs to work out, and they were slow to start the integration for at least one local library.

Recommendation:

NLS individual libraries currently using or wanting to join Kanopy may proceed with the discount program now. NLS will continue to monitor Kanopy and OverDrive so once their technical abilities match the CLSA requirements for a shared collection, NLS can further discuss the potential about using CLSA funds and how individualized caps, parameters, and so on can work as a group product.

It is recommended that the NLS Administrative Council consider approving the actions listed below:

- 1) Fuchs schedules two planned demonstrations of Filmocracy during February 2023 and issue invitations to NLS libraries.
- 2) Fuchs surveys NLS public libraries to gauge interest in Filmocracy.
- 3) Should 7 of the 41 libraries agree that there is interest in joining a shared collection, NLS Administrator would negotiate a shared contract for those libraries.
- 4) If there is a shared contract, Filmocracy would be added to the FY 2023-24 CLSA Claim Form.

(Any contract with a shared subscription is subject to the 5% administrative fee approved by the Council.)

Background

In the report of the NLS "Study of CLSA Cost Share Formula and Allocation of Funds," it was reported that some NLS members felt the CLSA claim form was 'confusing.' The report does not provide any further specifics regarding this comment. In the Recommendations section of the report, it notes "Consider a task force to develop an updated claim form."

Updated Menu of Items on the CLSA Claim Form

Attached to this memo is the FY 2022-23 NLS CLSA claim form for public libraries. The claim form was updated at the August 2022 NLS Executive Committee based on the data below of members' claim forms. In parentheses are the number of libraries which claimed the item in FY 2021-22.

- 1. NLS Library-to-Go Shared OverDrive Collection (27 libraries)
- 2. NLS Shared OverDrive eMagazine Collection (24 libraries)
- 3. NLS Shared Delivery (for MVLS and NBCLS) (16 libraries)
- 4. Additional funds towards NLS Library-to-Go Shared OverDrive Collection (17 libraries)
- 5. Additional funds towards NLS Library-to-Go Shared eMagazine Collection (5 libraries)
- 6. Link+ Software Subscription Fee (7 libraries)
- 7. Additional Delivery costs (Link+ Courier or NSCLS Postage for Delivery) (2 libraries)

Recommendation

Based on the CLSA Study recommendations, a task force should be formed to revise the format of the NLS CLSA Claim Form. The task force would convene, and will present a draft recommendation to the NLS Executive Committee at their April or May 2023 meeting, and the final revised form would be presented to the NLS Administrative Council at the June meeting, for adoption for the FY 203-24 year.

The task force will focus on the format of the form. Allowable items for the form are brought to the NLS Executive Committee to ensure compliance with the CLSA rules. Should the task force have recommendations for allowable items, that can be brought forth along with other recommendations.

Subject: Review of Use on List-serv for NLS Assistant and Deputy Directors

Date: January 26, 2023

Background

NLS received a request in early 2022 from Ann Hammond, the Director of the Sonoma County Library, regarding establishing an NLS list-serv for Assistant and Deputy Directors. The request was brought to the NSL Administrative Council for their consideration at the June 2022 Annual Meeting.

From Draft Minutes of NLS Administrative Council Meeting of June 15, 2022:

D. Consideration of Establishing NLS List-Serv for Assistant/Deputy Directors

Olawski presented the memo and reported that the Executive Committee discussed the merits of creating a new and separate listserv from the Directors listserv. Hammond stated that she had proposed the new listserv to create a space that would groom and prepare Deputy Directors for a larger role in their organization in the future. The space would be intended to allow for networking, sharing of ideas, and a community of learning. The space would be intended for information sharing only. Discussion ensued regarding Director participation on this new listserv. Brooks mentioned that they do not have a Deputy and so would not have representation on this listserv.

Motion to create a new listserv for Assistant and Deputy Directors. Hammond moved; Fink seconded. Vote taken by roll call. Alpine County and El Dorado County abstained. Motion passed.

Activity and Recommendation

To date, no activity other than postings from NLS staff has taken place on this listserv. NLS pays \$90 annually to maintain each listserv it hosts.

It is recommended that with no activity on this listserv, NLS Administrative Council either promotes the use of it with staff, or else makes a motion to discontinue the list-serv if there is no increase in use by June 30, 2023.
