Brown Act: This meeting abides by Cal. Gov't Code § 54953.

Cal. Gov't Code § 54953(b)(1) "Notwithstanding any other provision of law, the legislative body of a local agency may use teleconferencing for the benefit of the public and the legislative body of a local agency in connection with any meeting or proceeding authorized by law. The teleconferenced meeting or proceeding shall comply with all otherwise applicable requirements of this chapter and all otherwise applicable provisions of law relating to a specific type of meeting or proceeding." Cal. Gov't Code § 54953(j)(6) A "teleconference" is "a meeting of a legislative body, the members of which are in different locations, connected by electronic means, through either audio or video, or both."

Gov't Code § 54953 (b)(2) "Teleconferencing, as authorized by this section, may be used for all purposes in connection with any meeting within the subject matter jurisdiction of the legislative body. If the legislative body of a local agency elects to use teleconferencing, the legislative body of a local agency shall comply with all of the following:

- (A) All votes taken during a teleconferenced meeting shall be by rollcall.
- (B) The teleconferenced meetings shall be conducted in a manner that protects the statutory and constitutional rights of the parties or the public appearing before the legislative body of a local agency.
- (C) The legislative body shall give notice of the meeting and post agendas as otherwise required by this chapter.
- (D) The legislative body shall allow members of the public to access the meeting and the agenda shall provide an opportunity for members of the public to address the legislative body directly pursuant to Section 54954.3."

Gov't Code § 54953 (3) "If the legislative body of a local agency elects to use teleconferencing, it shall post agendas at all teleconference locations. Each teleconference location shall be identified in the notice and agenda of the meeting or proceeding, and each teleconference location shall be accessible to the public. During the teleconference, at least a quorum of the members of the legislative body shall participate from locations within the boundaries of the territory over which the local agency exercises jurisdiction, except as provided in subdivisions (d) and (e)."

# Board of Directors Special Meeting Minutes March 5, 2024

**1.** Meeting called to order at 1:02 p.m. by Chair, Duran.

#### 2. Roll Call

Present were: Crystal Duran, Belvedere-Tiburon Library; Jennifer Baker, Benicia Public Library; Christopher Veach, Lake County Library; Damon Hill, Larkspur Public Library; Lana Adlawan, Marin County Free Library; Mellisa Hannum, Mendocino County Library; Anji Brenner, Mill Valley Public Library; Anthony Halstead, Napa County Library; Melinda Cervantes, St. Helena Public Library; Linda Kenton, San Anselmo Public Library; Catherine Quffa, San Rafael Public Library; Suzanne Olawski, Solano County Library; and Erika Thibault, Sonoma County Library. Also attending, Carol Frost, NorthNet/Pacific Library Partnership, and Jacquie Brinkley, NorthNet/Pacific Library Partnership.

#### 3. No Public in attendance.

#### 4. Consent Calendar

Motion to approve Consent Items. Baker moved; Thibault seconded. Vote taken by roll call. Motion passed with one abstention.

### 5. Discussion of NBCLS CalPERS Unfunded Liability Payoff

Yon presented the options for payoff of the NBCLS CalPERS unfunded liability as requested by the NBCLS Board at their June 2023 annual meeting. Yon explained that the payoff amounts provided in the packet are an estimate at this time and until NBCLS presents a date of payoff to CalPERS, the estimates can be used for the Board's consideration.

There was discussion regarding the ongoing obligation for NBCLS with any of these payment plans. You clarified that Option #2 is the only payment that would fully terminate NBCLS from any further obligation to CalPERS. The other options are partial payments and accrual will continue based on CalPERS annual investment returns. Option #1 would reduce the annual amount significantly but would not terminate the on-going obligation. Option #3 is the annual required payment with a pre-payment discount if paid by July 31, 2024.

Yon noted that in addition to the CalPERS payment, NBCLS also has annual retiree medical costs and government reporting fees (GASB) that will be presented in the annual budget for Board approval at the annual meeting in May or June 2024.

Board members asked about individual payments on the CalPERS obligation to reduce amount owed by libraries who could afford to make the larger payment. You clarified

that NBCLS as the entity has the obligation with CalPERS and no individual library can pay off their share entirely, as the obligation continues for the entire entity if payment is not made in full. Members discussed setting up individual trust accounts within their jurisdictions to set aside CalPERS payments.

Discussion continued among members as to their authorization of approving a higher level of payment such as the #1 or #2 options and noted that payment at that level would require County administration or library commission approval.

Duran asked members of their interest in Option #1. The majority of members agreed to this Option with 2-3 members unable to commit at this time.

Yon explained that CalPERS will require a specific payoff date to obtain a payment amount. Thibault stated that Sonoma could not commit to any additional payment beyond Option #3 until after April 10, 2024.

Duran suggested that NBCLS make the FY 2024/25 annual payment of Option #3 with the pre-payment discount and plan for FY 2025/26 to pay off the Unfunded Annual Liability (Option #1 model) next year (2025). The NBCLS Board should meet in January 2025 to review the estimated payment, specify a payoff date, and plan for payment by July 31, 2025.

First Motion for NBCLS to use the estimate of \$114,618 from Option #3 with the prepayment discount to make the FY 2024/25 annual UAL payment before July 31, 2024.

Thibault moved; Kenton seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

Second Motion for NBCLS to meet in January 2025 to determine a payoff date and plan for the FY 2025/26 UAL payment using the Option #1 model.

Thibault moved; Kenton seconded. Vote taken by roll call, all votes in favor, motion passed unanimously.

#### 6. Set Next Meeting Date

The setting of the next meeting date was deferred until the NBCLS courier services contract is available for presentation and approval. The courier services Request for Proposal is to be issued in early April. Brinkley will issue a Doodle Poll after the courier RFP calendar has been established.

#### 7. Announcements

San Rafael Public Library has posted recruitment of a new Library Manager.

**SUBJECT: Award of NBCLS Delivery Contract**

#### **Background**

The existing NBCLS courier contract with Right Now Couriers will expire June 30, 2024. The current contract (originally made with Sprint Courier - Right Now Couriers acquired Sprint on April 1, 2022) began July 1, 2020 as a 1-year contract with an option to continue for three (3) additional years in one-year increments which NBCLS approved annually. The option period has expired, and a new delivery Request for Proposal was required to be issued.

#### **RFP Process**

NorthNet Library System, on behalf of the North Bay Cooperative Library System, issued a Request for Proposal to contract for delivery services for FY 2024/25, with an option to continue for **four (4) additional years** in one-year increments, by mutual consent of the NLS and the courier vendor, among six NBCLS libraries – Benicia, Solano County, Lake County, St. Helena, Mendocino County and Sonoma County.

Two proposals were received, reviewed and evaluated using a rubric of criteria to address requirements as outlined in the RFP. Evaluation of each proposal included the following:

- Competitive pricing
- Years in business, preferably in comparable work
- Location of operations
- Management structure
- Use of dedicated driver and dedicated vehicle for delivery
- Completion of RFP

Quotes from the two couriers were as follows:

Right Now Couriers \$20,300/mo = \$243,600/year
 FasTrack Courier Inc. \$22,220/mo = \$266,640/year

Upon review of the written RFPs by 4 reviewers, Right Now Couriers scored higher than FasTrack Courier Inc in most categories and higher overall based on their delivery experience and completion of the RFP. Right Now Couriers has a long and stable relationship with NBCLS and confidence is high in their ability to perform. Right Now Couriers also came in as the lower of the two bids.

#### Recommendation

The RFP includes the following for the terms of the contract:

The contract term shall be from **July 1, 2024 to June 30, 2025**, with an option to continue for **Four (4)** additional years in one-year increments by mutual consent of the NLS and Vendor. The contract includes a maximum of three percent (3%) annual CPI increase and a fuel surcharge fee if the California average price of unleaded fuel exceeds \$5.50 price per gallon. This period is predicated upon the need for program continuity and is intended to provide program stability through uninterrupted service. The plans to negotiate extensions with the winning contractor assuming: (a) good performance on the contractor's part, (b) continued requirement for the services, (c) the availability of funds, (d) the status of the competitive market, and (e) the continuation of services on a reasonable cost basis. Negotiated contract extensions without formal competition is an NLS prerogative, not a contractual right.

NBCLS may consider awarding a contract to either Right Now Couriers or FasTrack Courier Inc.

Subject: Consideration of Revised 2024 Retiree Health Insurance

Date: June 4, 2024

#### **Background**

At the June 9, 2023 meeting, the NBCLS Board approved a \$6,060 annually for the retiree health care and prescription costs for 2024. The monthly reimbursement cap is based on actual costs.

Since that time, the retiree is noting that her out-of-pocket prescription costs have increased significantly, and it has been verified that the monthly health care premium will increase 11.7% commencing in July.

The actual monthly health care costs for July – December 2024 are estimated to be \$4,776 for six months. The current retiree will be compensated \$3,030 for January – June 2024, but the remaining six (6) months of \$3,030 for July-December 2024 is considerably lower than these costs.

Based on this, and acknowledging that the Board has already approved a budget for FY 2023-24, the Board may consider increasing the monthly cap for July 2024 to December 2024 for an additional \$1,746, for a revised total annual maximum of \$7,806.

#### Recommendation

It is recommended that the Board of Directors adopt a resolution that states:

- (a) It will annually determine by Board action if it will provide retiree health insurance for the following calendar year, and
- (b) If so, it will determine how much the System will pay toward the monthly premium for the retiree during that calendar year. NBCLS may consider an increase of the monthly reimbursement to cover increased cost to retiree in the 2024 calendar year.

It is further recommended that the Board of Directors pass a motion to continue offering the currently covered retiree health insurance for calendar 2024, with the retiree choosing the health plan during open enrollment and with NBCLS reimbursing the retiree monthly up to a specific amount for the plan, and that said retiree may elect to cover dependents at their own expense.

Subject: 2025 Retiree Health Insurance

#### **Background**

Since 2014, the Board of Directors has agreed to annually approve continuing retiree health insurance and to pay only the rate set for single people receiving Medicare. At the March 2020 Board meeting, the Board approved continuation of payment of the retiree health insurance with the following provisions:

The retiree will select their own plan in open enrollment and provide the NorthNet (NLS) Fiscal Administrator with documentation of coverage and statement of plan fees. NBCLS will reimburse the retiree for a portion of the insurance premium beginning in calendar year 2021 with a cap identified by the Board, and the retiree's medical reimbursement claims to be inclusive of prescription costs and other medically related out-of-pocket expenses. The NLS Fiscal Administrator will be authorized to establish the payment structure with the retiree. Ongoing coverage of retiree health benefits will continue to be reviewed annually by the NBCLS Board, and costs for coverage incurred by NBCLS will be shared among NBCLS members using the cost-sharing formula approved at the Board meeting.

#### **Activities and Considerations**

In May 2023, the Board approved\$6,060 annually for the retiree health care and prescription costs for 2024. The retiree is noting that her annual out-of-pocket prescription costs are increasing considerably, and the health care costs are rising over 3%. The retiree notes that some of the costs increase twice annually.

Based on this, the Board may consider approving \$11,311 a total of annually for the retiree health care and prescription costs for 2025. The monthly reimbursement will be based on actual costs.

#### **Recommendation:**

It is recommended that the Board of Directors adopt a resolution that states:

(a) It will annually determine by Board action if it will provide retiree health insurance for the following calendar year, and

At the March 5, 2024 meeting, the NBCLS Board approved the FY2024-25 CalPERS Annual Unfunded Liability discounted Pre-Payment Option of \$114,618 to be paid in full by July 31, 2024. NorthNet Library System Accounting will mail out the CalPERS cost-share invoices to member libraries on July 1<sup>st</sup> requesting that payment be made no later than July 25, 2024.

The FY2024-25 budget includes the \$114,618 CalPERS prepayment amount; the \$11,256 retiree medical costs comprised of an additional \$1,746 of funds for July to December 2024 increasing the approved Year 2024 annual medical reimbursement cap from \$6,060 to \$7,806 and the proposed Year 2025 six (6) months medical reimbursement of \$4,830 for January 2025 to June 2025, and \$350 for the annual GASB 68 Valuation Report fee. For additional information, please refer to Attachments 3 and 4.
